 delivered to the original owner thereof.
- 2. This warranty will become void and of no force or effect whatsoever when any of the above mentioned products;
 - a. Are used to carry loads exceeding their rated capacity, or
 - b. Are not used for its intended purpose, or
 - Have been altered or repaired outside of MBC's factory in any way without MBC's prior written consent so as in its
 judgement to affect their capacity, stability, or
 - d. Have been subject to misuse, neglect, dirt, accidents, modifications damage due to the use of improper or unsuitable oils or other lubrications; or
 - e. Have been improperly used or not maintained in accordance MBC's recommendation or
 - f. Have not adhered to maintenance procedures from MBC and their suppliers' instructions, or
 - g. Have had any or all of MBC's identification marks altered, obliterated, removed, concealed; or
 - h. Have any parts thereof damaged by reason of defect in other parts of the unit not covered by this warranty.
- MBC makes no warranty in respect of trade accessories manufactured by others, the same being subject to warranties, if any, of their respective manufacturers. Our warranty coverage is applicable solely to products manufactured by MBC.
- 4. Trade components, including engines, pumps, hydraulic cylinders, power take-offs, axles, wheels, parts, etc. are only guaranteed on behalf of their suppliers insofar as they are guaranteed by their makes. No warranty in respect thereof is given by MBC itself and MBC shall not be liable for any defects therein. Any claims related to these components will be directed to their individual warranty terms.

This warranty is expressly limited to the replacement or repair at its factory at Germiston or such other place that MBC may designate, of any such products or parts of such products as shall be returned to it within the period or up to the kilometres obtained. Refer to clause 1 above, with transportation charges pre-paid by the owner. - 6. This warranty does not obligate MBC to bear the costs of labour in replacing defective parts. Any labour costs associated with the replacement of defective parts shall be the responsibility of the owner, if claimed by MBC
- 7. This warranty does not obligate MBC to bear the costs of loss of production, time, transportation charges or any other consequential damages, which the owner may suffer because of product defects.
- 8. MBC reserves the right, under its product improvement policy, to change design or construction details and to furnish equipment without reference to specification.
- 9. Please be aware that all warranty claims are subject to inspection by our representatives. Once the inspection is complete and it is confirmed that the issue falls within the scope of our warranty coverage, we will proceed with the appropriate repair.
- 10. No warranty, express or implied, is made or authorized to be made and no obligation is assumed or authorized to be assumed with respect to the products of MBC other than that herein set forth.
